## **1** September Quarter Results

#### 1.1 Headline net operating balance

The September Quarter 2023 Headline Net Operating Balance (HNOB) for the General Government Sector (GGS) was a surplus of \$351.2 million. This is \$40.0 million lower than the September year to date budget of a surplus of \$391.3 million (Table 1.1.1 refers).

The decrease in the HNOB reflects lower than anticipated Commonwealth grants and taxation revenue, partially offset by lower expenses.

**Note** (1): The superannuation return adjustment is added to the Uniform Presentation (UPF) Net operating balance to make up the Headline net operating balance. Together with transactional earnings revenue, this adjustment reflects the long-term target annual return on superannuation investment assets of 7.54 per cent per annum.

The largest component of GGS revenue is from own-source taxation, followed by Commonwealth Government through GST and grants.

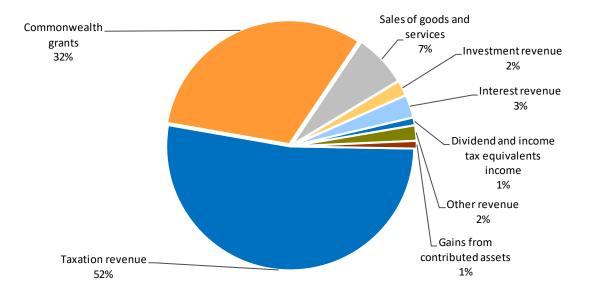
#### 1.2 Total revenue

Total revenue for the GGS as at 30 September 2023 was \$2,385.1 million. This is \$81.0 million lower than the September year to date budget of \$2,466.1 million. This is mainly due to:

- lower than expected Commonwealth Grants of \$27.1 million predominantly in relation to lower GST revenue, Financial Assistance Grants, as well as the timing of payments received;
- lower than expected own-source taxation revenue of \$25.4 million largely due to lower than expected payroll tax from employment agencies; and
- lower than expected sales of goods and services from contracts with customers of \$17.3 million attributed to lower regulatory fees including permits and licences.

Chart 1.2.1 below depicts the components of General Government Sector revenue for the September Quarter YTD 2023 Actual.

#### 1.3 Total expenses

Total expenses for the GGS as at 30 September 2023 were \$2,094.0 million. This is \$35.6 million lower than the September year to date budget of \$2,129.6 million. This is mainly due to:

- lower grants and purchased services of \$13.9 million associated with the timing of payments;
- lower than expected other operating expenses of \$12.1 million attributed to lower than budgeted insurance claims expenditure; and
- lower interest expenses of \$10.2 million reflecting the timing of projected borrowings.

Chart 1.3.1 below depicts the components of General Government Sector expenses for the September Quarter YTD 2023 Actual.

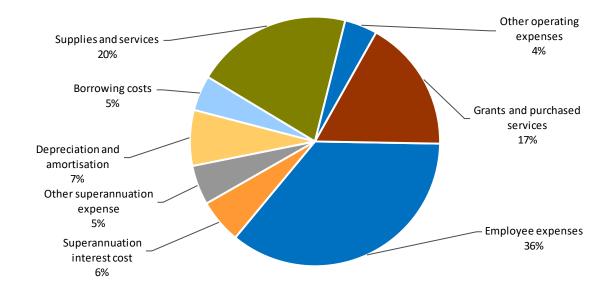


Chart 1.3.1: Components of General Government Sector expenses (%)

#### 1.5 Net debt

The net debt of the GGS as at 30 September 2023 was \$6,175.2 million, an increase of \$484.9 million from the 30 June 2023 result of \$5,690.3 million. This variance largely reflects lower cash and deposits reflective of prevailing cash flow requirements.

#### 1.6 Net financial liabilities

Net financial liabilities of the GGS as at 30 September 2023 were \$12,379.4 million, in line with the 30 June 2023 result of \$12,309.6 million.

#### 1.7 Net worth

Net worth of the GGS as at 30 September 2023 was \$19,658.6 million, in line with the 30 June 2023 result of \$19,569.7 million.

## Attachment A – Accounting Basis

This quarterly consolidated financial management report has been prepared to meet the requirements of section 26 of the *Financial Management Act 1996* (FMA).

This special purpose financial report summarises the financial performance and position of the Territory for the quarter ending 30 September 2023. The Territory's financial statement presentation complies with AASB 1049: 'Whole of Government and General Government Sector Financial Reporting' and is consistent with Australian Accounting Standards.

The 2022-23 Audited Outcome reflects the audited Consolidated Annual Financial Statements. The 2023-24 Budget reflects the published 2023-24 Budget.

This report provides financial management information and is not intended to form an audited financial report. Some estimates and assumptions have been necessary to ensure this information is provided within a useful time frame. Any differences will relate primarily to the accounting treatment of specific issues and elimination of internal trading, rather than non-disclosure of the whole of government financial position. Transactions and balances between government-controlled entities have been eliminated.

On 3 July 2023, the Calvary Public Hospital Bruce transitioned to Canberra Health Services and was renamed the North Canberra Hospital (NCH). Operational matters for the NCH are reflected in the Operating statement and Statement of cash flows for the quarter ending 30 September 2023. The value of assets and liabilities included in the consolidated Balance sheet represents the opening balance of these assets and liabilities at the beginning of the quarter. Negotiations to confirm just terms compensation in relation to this transition were still ongoing and at the time of finalising these financial statements and any financial impacts in relation to just terms compensation have not been included.

Certain columns may not add due to the use of rounded numbers as all amounts in the Territory Government's financial statements have been rounded to the nearest thousand dollars (\$'000).

#### Headline net operating balance (HNOB)

The HNOB is the ACT Government's key measure of the public finances, calculated as the difference between revenue and expenses resulting from transactions, plus the superannuation return adjustment.

The superannuation return adjustment, together with transactional revenues, reflects the long-term target annual return on the investment assets of CPI +4.75 per cent per annum (currently 7.54 per cent). This adjustment is made as under the Government Finance Statistics reporting framework capital growth on financial assets is not included as transactional revenue in the net operating balance. This approach understates investment revenue and overstates the net superannuation expense related to the superannuation liability.

#### Net debt

Net debt reflects the sum of deposits held, advances received and borrowings minus the sum of cash and deposits, advances paid, investments, loans and placements. Net debt is a useful measure to judge the overall strength of the Government's fiscal position. A positive position indicates that cash reserves and investments are lower than gross liabilities, placing a call on future revenue to service these liabilities. A negative position indicates that cash reserves and investments are greater than gross liabilities. The ACT measure of net debt excludes the impact of superannuation related investments.

#### Net financial liabilities

Net financial liabilities include unfunded superannuation liabilities and provide a broader measure than net debt. Net financial liabilities are calculated as total liabilities less financial assets (such as cash reserves and investments). The measure includes all non-equity financial assets but excludes the value of equity held by the General Government sector in public corporations.
