1. Page 125 Table 1: Revised Output Classes – Total Cost and Controlled Recurrent Payments (CRP)

Output Class 2: Environment

Due to a miscalculation, Output Class 2: Environment reported incorrect sub-output splits between its sub-output classes for variations in CRP and Total Cost since the 2023-24 Budget.

For the Environment sub-output class, the total cost variation was reported as \$12,911,000, and the total revised cost reported as \$40,577,000. The correct amount for the total cost variation is \$4,085,000 and the total revised cost is \$31,751,000. The CRP variation was reported as \$5,461,000, and the total CRP revised budget reported as \$31,190,000. The correct amount for the CRP variation is \$2,857,000 and the total CRP revised budget as \$28,586,000.

For the Parks and Conservation sub-output class, the total cost variation was reported as -\$2,493,000, and the total revised cost reported as \$64,349,000. The correct amount for the total cost variation is \$1,915,000 and the total revised cost is \$68,757,000. The CRP variation was reported as \$1,136,000, and the total CRP revised budget reported as \$45,703,000. The correct amount for the CRP variation is \$1,275,000 and the total CRP revised budget as \$45,842,000.

For the Heritage sub-output class, the total cost variation was reported as \$1,039,000, and the total revised cost reported as \$6,124,000. The correct amount for the total cost variation is \$68,000 and the total revised cost is \$5,153,000. The CRP variation was reported as \$315,000, and the total CRP revised budget reported as \$4,191,000. The correct amount for the CRP variation is \$312,000 and the total CRP revised budget as \$4,188,000.

For the Water sub-output class, the total cost variation was reported as -\$4,477,000, and the total revised cost reported as \$6,530,000. The correct amount for the total cost variation is \$912,000 and the total revised cost is \$11,919,000. The CRP variation was reported as -\$2,193,000, and the total CRP revised budget reported as \$9,137,000. The correct amount for the CRP variation is \$275,000 and the total CRP revised budget as \$11,605,000.

For the Building Reform sub-output class, the total cost variation was reported as -\$605,000, and the total revised cost reported as \$2,198,000. The correct amount for the total cost variation is \$376,000 and the total revised cost is \$3,892,000.
