# **Building Approvals – February 2024**

#### Number of building approvals in the ACT decreased in February 2024.

The number of residential building approvals in the ACT (in original terms) decreased 86.1 per cent in February 2024, driven by a fall in approvals for both other residential dwellings (-94.9 per cent) and detached houses (-66.2 per cent). A key driver was that no apartments were approved in February. Through the year to February 2024, the total number of residential approvals decreased by 84.2 per cent.

In trend terms, the total number of residential dwelling approvals in the ACT decreased by 22.8 per cent to 234 approvals in February 2024, to be 27.3 per cent lower through the year.

Nationally, the total number of dwelling approvals (in seasonally adjusted terms) decreased by 1.9 per cent in February 2024. The ABS noted that approvals for private sector dwellings excluding houses fell 24.9 per cent in February 2024 in seasonally adjusted terms, driven by a fall in the number of approved large apartment projects. Approvals for private houses rose 10.7 per cent in the same period. The total number of dwellings approved were 5.8 per cent lower through the year.




