| Issue the proposal will address: | This proposal will fund two new MACH nurses to provide support, information and health advice to families and parents in the ACT. |

- The funding will start in 2017-18.

- The costing is based on salary and on-costs for two new nurse coordinators (level RN 3.1). The two positions will be ongoing.
