

<b>Costing Methodology Used:</b>
<b>- Costing Technique:</b>
Treasury has costed this commitment as having no financial impact as it represents the reorganisation of existing resources in the courts system.
<b>- Proposal Parameters:</b>
The costing assumes that administrative expenses associated with the program would be absorbed by the Justice and Community Safety Directorate.
<b>Caveats or qualifications to the costing:</b>
The appointment of a full-time, dedicated Domestic Violence Magistrate could have implications for the flexibility of conducting cases and other matters in the Magistrates Court.
<b>Other Comments:</b>
The existing Family Violence Court within the Magistrates Court currently sits every Tuesday to hear offences that satisfy certain provisions of the <i>Domestic Violence and Protection Orders Act 2008</i> . At any one time, more than one Magistrate may be sitting as the Family Violence Court Magistrate.
