



Other Information
Costing Methodology Used:
- Costing Technique:
Treasury has costed this commitment as a fixed level of \$15 million in 2017-18. Treasury considers that this level of capital funding is sufficient to undertake the scope of the Stage 2 works, based on preliminary planning documentation.
- Proposal Parameters:
Construction is anticipated to commence in 2017-18 and take one year to complete. Depreciation has been calculated on a straight-line basis over a 50-year period. Repairs and maintenance expenses are costed at zero per cent of the capital cost in the first year after construction, one per cent the year after, and two per cent ongoing thereafter. The cost of financing has been calculated at 2.5 per cent.
Caveats or qualifications to the costing:
The final scope would be subject to detailed design and planning studies. The costing does not include any expenses for relocation and rental assistance for Belconnen Arts Centre Incorporated during the construction of the Stage 2 works. The costing does not include any improvements to the foreshore or pathway linkages; it does however include some alterations to the existing facility. The costing does not include any additional administrative, utility and/or other costs of a larger Belconnen Arts Centre.
Other Comments:
There would be maintenance costs of \$300,000 per annum from 2020-21 onwards. Treasury's costing differs from that submitted mainly due to the inclusion of repairs and maintenance expenses. Design work for the Belconnen Arts Centre was funded in the 2012-13 Budget and is well advanced.
